
Where data is described, this technical paper uses the August 2023 version of the G2HSet.

Errata

After a third round of quality checks, the healthcare system introduction date for Nigeria has been readjusted from 1999 to 1975. On the basis of new data and information obtained from expert interviews and an extensive literature review, it became clear that the implementation of the Basic Health Service Scheme (BHSS) in the context of Nigeria's third National Development Plan (1975-1980) met all the criteria for representing the introduction of the healthcare system under public responsibility (see subsection 2.3). As part of this, the entire population was entitled to receive healthcare (Adeyemo 2005, 5). In the Nigerian federal system, the regulatory framework was developed by the federal government, while the states had to ensure the provision of care (Scott-Emuakpor 2010, 6-7).
